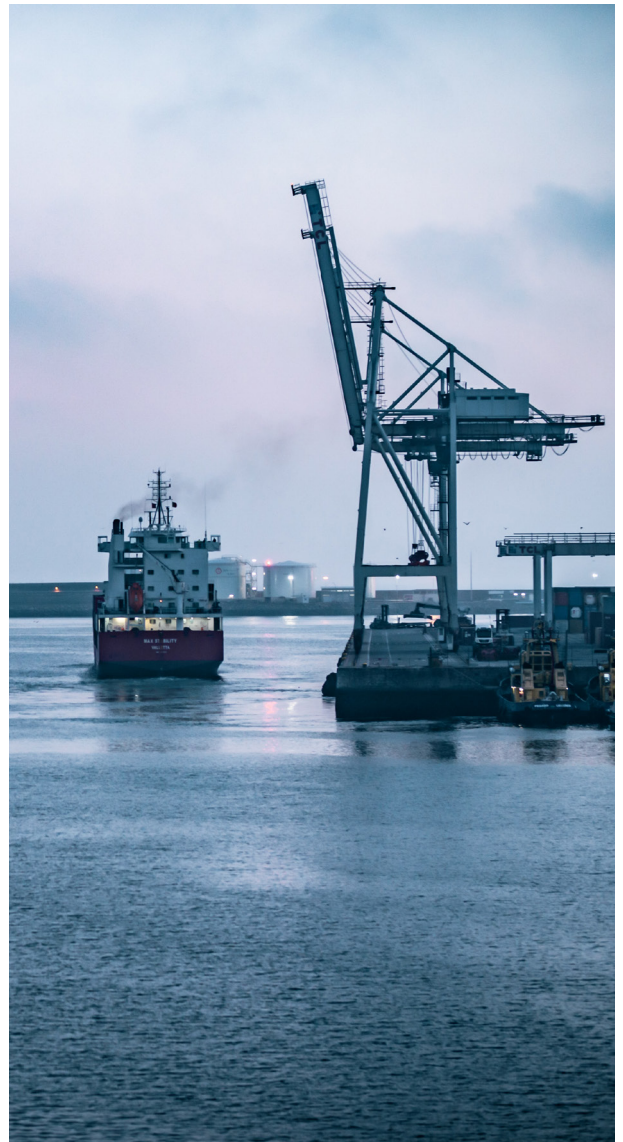
OVERVIEW

In 2021, the Maltese Ship Registry secured its position as the sixth largest ship register in the world and the largest ship register in Europe, with circa 85 million gross tonnage registered. This impressive figure is the product of innumerable factors, however one of the most conspicuous factor is that the Maltese islands are perfectly located at the very heart of one of the busiest seaways in the world – the Mediterranean.

The strategic location of the islands is complemented by other elements that include the dedicated Maltese labour force, contemporary fiscal incentives and a robust regulatory environment. Malta has remained at the leading edge of maritime legislation within the Mediterranean and around the globe by consistently employing a tried-and-true methodology of regular review and reform. As a result, Malta's well-earned successes are celebrated both locally and amongst the international maritime community.

Malta boasts a long maritime tradition, in fact Malta has been included on the White List and on the Low Risk Ship List of the Paris Memorandum of Understanding. Malta has produced a ship registry that permits any type of vessel used in navigation to be registered under the Maltese Flag, including vessels self-propelled or not, such as barges, pontoons, floating establishments, installations or structures, oil rigs and any vessel under construction.

Malta also offers a number of incentives to owners, registered charterers and financiers. These incentives are also complemented by progressive reductions on costs relating to registration and tonnage.
